विद्यापीठ अधिकार मंडळानी येळोयेळी घेतलेल्या निर्णयानुसार निश्चित केलेल्या मार्गदर्शक तत्वानुसार सर्व विद्याशाखांतील सर्व अभ्यासक्रमांच्या प्रथम वर्ष ते अंतिम वर्षांतील विद्यार्थ्यांच्या मार्च/एप्रिल, २०२२ (नियोजन जून, २०२२) परीक्षांचे आयोजन पारंपारिक (ऑफलाईन) पध्दतीने करण्यात आलेले आहे. याबाबतची मार्गदर्शक तत्वे व सूचना खालीलप्रमाणे :

१. शैक्षणिक वर्ष २०२१-२२ मधील मार्च/एप्रिल, २०२२ पदविका, पदवी व पदव्युत्तर अभ्यासक्रमांच्या नियमित व अनुशेषित तसेच बहिःस्थ, श्रेणीसुधार B.A. to B.A., B.Sc. to B.Sc. इत्यादिसाठी आवेदनपत्र भरलेल्या पात्र विद्यार्थ्यांच्या परीक्षांचे आयोजन टप्प्याटप्प्याने २० जून, २०२२ पासून फक्त पारंपारिक (ऑफलाईन) पध्दतीने करण्यात आलेले आहे.
२. संबंधित परीक्षांची येळापत्रके विद्यापीठाच्या [www.unipune.ac.in](http://www.unipune.ac.in) या संकेतस्थळावर टप्प्याटप्प्याने प्रसिध्द करण्यात येतील. विद्यार्थ्यांनी येळोयेळी वरील संकेतस्थळावरून माहिती घ्यावी.
३. प्रथम वर्ष ते अंतिम वर्ष विद्यार्थ्यांच्या मार्च/एप्रिल, २०२२ या उन्हाळी सत्राच्या परीक्षा या समकक्ष विषयानुसार आयोजित करण्यात आलेल्या आहेत. विद्यार्थ्यांनी विद्यापीठ संकेतस्थळावरील अभ्यासक्रम अंतर्गत जाहीर करण्यात आलेले समकक्ष विषय जाणून घेऊन त्याप्रमाणे अभ्यास करून परीक्षा द्यावी.
४. विद्यापीठ परिपत्रक क्र.१९/२०२२, दिनांक ५ जून, २०२२ नुसार नियमित सम सत्राच्या परीक्षेमधील दोन पेपरमध्ये किमान दोन दिवसांचे अंतर ठेवून सदर परीक्षा आयोजित करण्यात येत आहे.
५. तसेच लेखी परीक्षेसाठी सर्व विद्यार्थ्यांना प्रत्येक तासामागे १५ मिनिटांचा अतिरिक्त वेळ वाढवून देण्याबाबत सर्व संबंधितांना तसेच महाविद्यालयांना परिपत्रक क्र.१९/२०२२ अन्वये सूचित करण्यात आलेले आहे.
६. शैक्षणिक वर्ष २०२१-२२ मधील मार्च/एप्रिल, २०२२ पदविका, पदवी व पदव्युत्तर अभ्यासक्रमांच्या नियमित व अनुशेषित तसेच बहिःस्थ, श्रेणीसुधार B.A. to B.A., B.Sc. to B.Sc. इत्यादिसाठी आवेदनपत्र भरलेल्या पात्र विद्यार्थ्यांच्या परीक्षा या १०० टक्के अभ्यासक्रमांवर आधारित असतील.
७. विद्यार्थी ज्या पॅटर्नमध्ये (आराखडा) परीक्षा देणार आहेत त्याच पॅटर्नमधील प्रश्नसंच विद्यार्थ्यांना विद्यापीठ संकेतस्थळावर <http://exam.unipune.ac.in/Pages/PreviousQuestionPapers.html> येबलिकवर उपलब्ध करून देण्यात आलेले आहेत.

८. संबंधित महाविद्यालयाचे प्राचार्य/संचालक यांनी परीक्षावर्षाच्या बेटक व्यवस्थेचे नियोजन नियमानुसार करावे. विद्यार्थ्यांची बेटक व्यवस्था करीत असताना एक बेंचवर एकाच विद्यार्थ्यांची बेटक व्यवस्था करण्यात यावी. तसेच आवश्यकतेनुसार हवा व उनेड यासाठी फेन व विलेची पुरेशी व्यवस्था करण्यात यावी.

१०. परीक्षा केंद्रावर आवश्यकतेनुसार पाण्याची व्यवस्था, विद्यार्थ्यांची बेंग ठेवण्याची व्यवस्था व दिव्यांग विद्यार्थ्यांकरिता तळमजल्यावर विशेष खोलीची व्यवस्था करण्यात यावी.
११. विद्यार्थ्यांनी कोणत्याही परिस्थितीमध्ये मोबाईल/इलेक्ट्रॉनिक उपकरणे परीक्षा कक्षामध्ये आणू नयेत हे पूर्णपणे नियमबाह्य व आक्षेपाहं आहे. मोबाईल/उपकरणे हरविल्यास/चोरी गेल्यास/गहाळ झाल्यास त्याची संपूर्ण जबाबदारी संबंधित विद्यार्थ्यांची असेल. याबाबत संबंधित महाविद्यालयातील परीक्षा अधिकारी यांनी दक्षता घ्यावी.
१२. विद्यार्थ्यांनी परीक्षा सुरु होण्यापूर्वी अर्धा तास अगोदर परीक्षा केंद्रावर हजर राहणे अनिवार्य आहे. याबाबतच्या पूर्वसूचना संबंधित महाविद्यालयांनी विद्यार्थ्यांना देण्यात याव्यात.

१५. विद्यापीठ अधिकार मंडळाने घेतलेल्या निर्णयानुसार पदवी परीक्षा (बी.ए., बी.कॉम. व बी.एससी.) सोडून सर्व अभ्यासक्रमांच्या केंद्रिय मूल्यमापन प्रकल्प केंद्राबाबत (केंप) परीक्षा विभागामार्फत स्वतंत्रपणे पत्राव्दारे अवगत करण्यात येईल.
१६. केंद्रिय मूल्यमापन प्रकल्प केंद्र (केंप) प्राचार्य/संचालक यांना कळविण्यात येते की, परीक्षेच्या पहिल्या दिवसापासून केंद्रिय मूल्यमापन प्रकल्प चालू करण्यात यावे व तपासून झालेल्या उत्तरपत्रिका तात्काळ विद्यापीठ परीक्षा विभागात जमा करण्यात याव्यात. याबाबतची सूचनावलीचे पत्र स्वतंत्रपणे परीक्षा-छाननी व तालिनीकरण कक्षामार्फत प्रसिध्द करण्यात येईल.

१९. ज्या प्राध्यापकांना भरारी सदस्य पथक/वरिष्ठ बाह्य पर्यवेक्षक/स्थायी निरीक्षक परीक्षा आयोजनाबाबत परीक्षा विभागाकडून चेळोवेळी आदेश प्राप्त होतील त्यांनी संबंधित काम करणे हे महाराष्ट्र सार्वजनिक विद्यापीठ अधिनियम २०१६, कलम ४८(४) नुसार बंधनकारक आहे. संबंधित महाविद्यालयाच्या प्राचार्यांनी अशा प्राध्यापकांना नमूद कालावधीकरिता तात्काळ कार्यमुक्त करावे.
